Bausch + Lomb's Organic Growth 12% for the Second Quarter of 2014, over 90% Due to Volume Allergan Stockholders Encouraged to Call Special Meeting

Valeant to Announce Second Quarter 2014 Financial Results on July 31, 2014

LAVAL, Quebec, July 18, 2014 /PRNewswire/ -- Valeant Pharmaceuticals International, Inc. ("Valeant") (NYSE: VRX) (TSX: VRX) has filed an investor presentation with the Securities and Exchange Commission that will be used in meetings with Allergan's institutional investors and proxy advisors, the first of which is being held today, regarding calling a special meeting. The presentation includes a preview of certain results for the second quarter 2014, including 12% organic growth at Bausch + Lomb of which over 90% of the growth is due to volume increases.

"Bausch + Lomb continues to benefit from Valeant's decentralized operating model and we are thrilled with the feedback and early results of recent launches, including the *Ultra*[™] contact lens, BioTrue[®] contact lens and solution, Peroxyclear[™], Trulign[™] IOLs and Soothe XP and others," stated J. Michael Pearson, chairman and chief executive officer. "In addition, we announced yesterday that we received 510(k) clearance for the *VICTUS*[®] Femtosecond Laser Platform for laser-assisted lens fragmentation during cataract surgery which we believe will dramatically accelerate the adoption of this technology in the U.S. The results at Bausch + Lomb further validate our business model, which Allergan has no credibility in attacking. We believe the only way Allergan will come to the table is if their stockholders call a special meeting to remove directors and that stockholders deserve the right to be heard."
